

ADDENDUM TO THE  
**UNIVERSAL COMBINED CONTRACT | Puppy Name**

DATED: MARCH 25, 2023

Between Buyer's Name (BUYER/S) and Seller's Name (SELLER)

LET IT BE KNOWN THAT SELLER takes every reasonable precaution to ensure that Puppy is healthy and happy on, and before Adoption Day.

BUYER hereby acknowledges that they have read and understand their responsibility as an owner as outlined in the Health Warranty, the directions provided before adoption and those given on the day of transfer.

**INFECTIOUS DISEASES**

SELLER takes every reasonable precaution to avoid transmittal of contagious diseases. BUYER accepts that such diseases can be transmitted by means outside of SELLER's control including, but not limited to, people, objects and environments including Veterinary offices and staff.

If Puppy is diagnosed with any life-threatening illness BUYER hereby agrees to immediately contact the SELLER, from the veterinarian's office and provide permission for the attending veterinarian to discuss the case with SELLER or individuals of his/her choice. BUYER also hereby agrees to immediately return Puppy to SELLER at SELLER's request.

SELLER has completed all immunizations listed in Puppy's IMMUNIZATION RECORD and has tested Puppy with an industry standard antigen/parvovirus test before Puppy leaves SELLER's home. SELLER keeps the test results on file, associated with Puppy's microchip number, for a period of 90 days. Said test results are the sole property of SELLER and not for use by any other entity for any purpose.

If Puppy tests positive for Parvovirus within fourteen days of adoption, BUYER hereby agrees to return Puppy to SELLER on the day of the diagnosis with test results signed by the attending veterinarian. SELLER will provide a maximum refund in the amount of the ADOPTION FEE.

Failure to do any of the above will void BUYER's Health Warranty and result in absolving SELLER of any and all responsibilities and obligations.

DCDogFinders will not accept any Banfield diagnosis as a Warranted Disorder. We encourage you, as our customer, to develop a relationship with an established vet who will get to know, and take an interest in, you and your puppy.
